ORDINANCE AMENDING CHAPTER 74 NON-HIGHWAY VEHICLES OF THE VILLAGE OF WONDER LAKE MUNICIPAL CODE

BE IT ORDAINED by the President and Board of Trustees of the Village of Wonder Lake as follows:

SECTION 1: The Village of Wonder Lake hereby amends Ordinance 465, Section 74.07 Penalty, as follows:

Any person, firm or corporation violating any provision of this Section shall be fined \$50.00 for the first violation, \$100.00 for the second violation. A third or subsequent violation shall be a fine of not more than \$1,500.00 and the Village of Wonder Lake's cost of prosecution, including reasonable attorney's fees.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
