- **Swale Project** received good guidance from Army Corp of Engineers, working on permit, cover matts better than cover logs on banks; Trustee Palys informed the Board that will put in lifts to raise the creek and asked can use rock riffle/rip rap, Wellbank said can be done

Sewer and Water: Jacob Wellbank, Robinson Engineering – Present

- Hydrant Flushing will start next week on East Side and then the West Side
- Stonewater Wastewater Treatment Plant working on startup; will be going over plans for expansion, system built for the first 700 homes only; 38,500 gallons pumped out of Stonewater system and taken over to Meadows of West Bay, will be done every 1-2 weeks until Stonewater plant started up
- Spray Irrigation Systems startup depends on the weather
