### Engineering - Ryan Christensen, Robinson Engineering - Present

- Stonewater reviewing Phase 3 & 4
- MOWB Boat Ramp permit is still under review by the Army Corp

## Sewer and Water -Ryan Christensen, Robinson Engineering- Present

- Stonewater Wastewater Treatment Plant started it up this week, initial seeding, sludge shipped in from other communities, gradually adding so do not disrupt biologicals,
- Spray Irrigation Systems working overnight
- Woods Creek meeting with Jake about Disc Golf; layout set
- Woods Creek Water Treatment Plant was put in 2004-05, seeing failures in Booster Pumps, prices to rebuild 2 pump assemblies, in budget, need to get done, normal wear and tear
- Water Meters will need to put in budget to replace batteries. Batteries on outside of house

- Road Work Hickory Falls 1 & 2, White Oaks Bay preconstruction meeting tomorrow
- Trimming Bushes Thanked Village President Topf for trimming bushes in front of Municipal Center
