- Engineering Paul Rusko, Robinson Engineering provided and Engineering update. Stonewater earth work and storm water improvements for the next phase of development are underway.
- Sewer and Water Paul Rusko, Robinson Engineering provided a Sewer and Water update. The Stonewater water and waste water treatment plant expansion review is completed. Pavement patching related to water main repairs will take place in a week or so.
- Public Works Chuck Bissel, Public Works Director provided a Public Works update. Vandalization of street signs is increasing. Preparation for the 4th of July parade continues.
- Police Chief Redlin provided a Police Department update. Coffee with the Chiefs was a success. Chief Redlin met with the 4th of July Committee. Training for officers continues.
- General Affairs Trustee Reinhard provided an update with a printed report that detailed vandalism at Woods Creek Park and Disc Golf construction Phase 1 is installing tee pads and basket pads. Phase 2 will begin in mid July with baskets and signage installed.
- Financial Treasurer Dirr reported a meeting will be scheduled next week with the Wonder Lake State Bank.
- Pollinator Habitat Restoration and Enhancement Department Trustee Palys provided an update. Planting is taking place in five sites . 4,000 plants have been planted and there

remains 1,000 left to plant. A NICOR grant for \$5,000 was received to help with the cost of the plants.
