that were paused due to COVID will be reinstated in September.

• Meadows of West Bay Water Quality – Village President Dycus informed the Board that there has been poor water quality in Meadows of West Bay for a while and is now spreading to other areas/subdivisions on the same water line ; the iron is caused from sediment in the water tank that needs to be removed ; Robinson Engineering has a contract from the service company with the daily costs for the Board to review ; in order to get on the schedule the Village needs to sign the contract ; it will take approximately 2 to 3 days to complete the sediment removal process at \$4,300.00 per day ; Trustees discussed that this needs to get taken care of as soon as possible and should be considered an Emergency ; Village Attorney Curran informed the Board that a motion to authorize the Village President to sign the contract now is okay as long as the entire Board is in agreement and will approve and ratify the Village President's action at the next meeting.
