- **Migrant Arrivals & Potential Responses** the Village does not have a Metra station, but communities nearby do and are setting up ordinances, the Village may want to consider an ordinance, Village Attorney will be sending out the Elburn Ordinance to review since approximately the same size community as the Village ; Chief Redlin informed the Board that the Police Department position without an ordinance is that we are a community caretaker looking for the best interest of the people inside the bus and that the bus driver is the one who is vacating the bus (cold weather, food, etc) so can act on that, an ordinance will provide more for the Police to work with to make sure the people are safe and get to a place that can provide shelter and food.
