Meadows of West Bay – met with Lennar Homes and did a site meeting to discuss condition of binder and
pavement; working with their consultants, Mackey, to firm up the anticipated capacity of the wastewater
treatment plant

Public Works - Chuck Bissell - Present

- **3917 Greenwood Drive Demolition –** getting a few more quotes, not sure if house has asbestos but will be tested per state law, driveway and culvert will be removed
- Village Hall Roof found leak in Police Garage and has a lot of hail damage
- Parking lot and New Water Plant staked now for plowing

Police - Chief Crilly - Present

- Property Custodian has been hired, room is done and has begun the audit, proceeding professionally
- **Building Maintenance** Keith cleans the building 6 times per month and noticed a few things that may need repair, will put a list together for review
- **Bullet Proof Vest** required to provide officers vest, have provided Treasurer with information about a matching grant so can prepare for the future cost
- New Radio Services Contract Motorola has stopped repairing radios so as break will need to replace

• Pickle Ball Court – possible to construct court in the next year, between present basketball/hockey court and tennis court which is most economical location or more expensive option the narrow strip between basketball court, Village Hall and Land Conservancy; cost between \$25,000 and \$30,000; funds from this year budget would be down payment \$10,000; next year funds almost there so would use impact fees to finish pay, will have proposal in February; Trustee Palys suggested considering land in Wooded Shores; Trustee Dycus asked about overlaying the court over an existing court, Trustee Reinhard said possible but does not recommend that option because will affect the original court
