Lennar Homes will build out MOWB as intended to be built; Lennar Homes is currently building 31 subdivisions, 800 homes a year, uses an in house mortgage lender, everything is included (appliances, landscape packages, etc.), build smart homes; will be buying the fully developed home sites and parcel 2 (raw piece, have no plans now), 2 different ranch plans \$220,000 - \$270,000; duplexes have four floor plans \$180,000 - \$200,000; Townhomes are 2 story and will blend in with the current ones \$170,000 - \$195,000; set up now for 4 Homeowners Associations, looking in to 1 HOA with committees so will amend and restate; open to ideas for the Park Improvement Plan, talked with Trustee Reinhard about Tot Lot, Dog Park and additional parking spots, will send a plan; there are some issues to clean up with the Townhomes and Duplexes so will have to work with Planning and Zoning Commission; need to confirm development obligations from Village, will want infrastructure approved by Village, need to verify Irrigation can handle capacity, work on grading plan modification, need to confirm if Village is willing to reissue bonds, verify security for development and impact fees; finishing due diligence, want to be good partners and get this done, will meet with residents.
