NRB would need to keep sufficient funds in the escrow account so that payments could be made on time; what liability the Village would have and how there would need to be collateral/security written out so Village does not have to start making the loan payments; the watermain would go along Hancock Drive and then over to service the residents currently on the East Side Water Tower; that changes would need to be made to the Annexation Agreement if the project moved beyond this first step; that more information/assurances is needed before voting.
